VIII. Remuneration of Retired Govt. Officials:

- IX. Age Limit: 31/05/2025 will be considered as benchmark date for calculation of age and post qualification years of experience.
 - For retired officials' employment may continue up to 65 years of his/her age.

X. Work Experience:

Applicants have to submit a Supporting Document as a proof of Retirement from the post of Chief Engineer (CE) & Superintendent Engineer (SE).
